

## 2022 Summer Challenge Official Rules:

NO PURCHASE NECESSARY. A PURCHASE OR TRANSACTION WILL NOT INCREASE YOUR CHANCES OF WINNING.

SPONSOR. The Greenlight Scholarship Challenge (the “Sweepstakes”) is sponsored by College Greenlight, a division of Cappex.com, LLC (“Sponsor” or “Cappex”).

HOW TO ENTER. You may enter the Sweepstakes by doing the following: (a) Setting up a [cappex.com](http://cappex.com) profile (b) starting on 6/01/2022, add at least 5 colleges to your Cappex college list, and submit your active email through the form on the scholarship’s landing page or the Cappex Scholarship Center. Individuals who complete the foregoing steps and meet all other eligibility requirements contained in these Rules will be automatically entered for a chance to win the Sweepstakes. (Additional instructions: To be eligible to win a Scholarship Prize, applicants must submit their contact information through Cappex Formstack).

ELIGIBILITY: This Sweepstakes is open only to registered Cappex users who are residents of the fifty (50) United States and the District of Columbia, thirteen (13) years of age or older and currently enrolled (or will enroll within two years of the Sweepstakes) in an accredited post-secondary institution of higher learning (college, university, or trade school) located in the United States. Employees of Cappex (along with its contractors, affiliates, and subsidiaries) and their families are not eligible. Void where prohibited by law. Contestants residing in those areas where the contest is void may participate in the contest but may not win any prizes. Each entry must be submitted on an individual basis (i.e., no team, joint, or corporate entries) and all components of the entry must be the original creation of the submitting participant. Only non-commercial work may be submitted. Entries may not contain profanity, nudity, pornographic images, violent images, anti-competition messages, illegal material, or material that violates the rights of third parties. Entries may not include confidential information, trade secrets, trademarks or copyrighted material belonging to any person or entity other than the entrant absent a suitable license or permission agreement, proof of which is required. Entries containing any forbidden matter or material otherwise deemed by Sponsor to be inappropriate will be disqualified. Online entries will be deemed submitted by the authorized account holder of the email address submitted at time of entry.

CONTEST PERIOD. Entries will be accepted online starting on June 1, 2022. All online entries must be received by September 1, 2022.

WINNER SELECTION. Two winners will be selected via random drawing from all eligible Sweepstakes entries (“Winner”). If a Winner is disqualified for any reason, an alternate Winner will be selected through additional random drawings as many times as necessary. The odds of winning will be determined by the number of entrants into the Sweepstakes.

PRIZES. Each winner will receive a \$500 scholarship (“Scholarship Prize”) in the form of a direct payment to the accredited post-secondary institution of higher education attended by the winner (once the winner has enrolled in an accredited post-secondary institution of higher education and submitted proof of enrollment to Sponsor or Sponsor’s scholarship administrator). The awarding of any Scholarship Prize is contingent upon full compliance with these Official Rules and subject to Sponsor’s verification of Applicant and Applicant’s submission. Applicants agree to be bound by Official Rules and agree that if any Winner is found to have violated the Official Rules or otherwise does not meet eligibility criteria, Scholarship Prize will be forfeited, and an alternate Winner will be selected. Winners will be notified via email address used to enter the Sweepstakes within 14 days after the winners have been determined, and no later than 30 days following the end date of the contest. Inability to contact a winner may result in disqualification and selection of an alternate winner.
